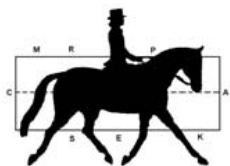

ENTRY GUIDELINES

ENTRIES: This Event is two (2) shows – Lemonade Daze I and Lemonade Daze II. Each show requires a separate and complete entry. Entries must be postmarked by the CLOSING DATE to avoid LATE FEE. **MAIL ENTRIES TO SHOW SECRETARY (do not mail entries to Las Colinas Equestrian Center).** Make checks payable to the Dallas Dressage Club. No post dated checks. Returned checks will be charged \$35. Competitors making payments for fees which are non-negotiable are subject to reporting and possible fines by USEF (GR 1508). Stop Payment orders will be subject to USEF Non-Negotiable Funds (GR 1508.1). Credit cards are NOT accepted. Entries are accepted by Show Secretary on a first come/first serve basis. Entries MUST be filled out in their entirety, with required documentation and payment. Entries with missing information or documents will result in a \$20 INCOMPLETE ENTRY FEE. All information MUST be available at check-in. A negative Coggins Test dated within twelve (12) months of show date must accompany entry. **Horse's name on Coggins Test MUST match Horse's name (registered/show name) on entry form.** Horse's registered/show name MUST be used on all documentation. Haul Ins are allowed. Horses not participating in classes are NOT allowed. Bridle Numbers MUST be worn AT ALL TIMES when a horse is out of stall. ***Management reserves the right to return entries that are incomplete or inaccurate at anytime.***

LATE ENTRIES: Entries not postmarked by the CLOSING DATE will be considered LATE. Late entries will be charged an additional \$20/SHOW, and will be accepted only if space is available. If classes are oversubscribed, a waiting list (in the order of draw) will be maintained by the Show Secretary. No entry will be allowed once a class has started.

CHANGES: Any change made after closing date will incur an additional \$20/SHOW/CHANGE. Changes must be made in writing must be submitted to the Show Secretary. Change notifications MUST be submitted by 8 am (morning change) and/or 12 pm (afternoon/evening) change.

CREDENTIALS: All entries MUST include a copy of horse/owner/rider/trainer USEF cards or non-member fee AND horse/owner/rider/trainer USDF cards or non-member fee. Also include a copy of USDF horse Identification card. Entrants participating in Great American/USDF Qualifying Classes MUST include proof of USEF Annual or Lifetime Horse Registration as well as USDF Lifetime Horse Registration. All Freestyle entrants must include a copy of a qualifying test (NAYRC qualifiers excluded). Ponies not exceeding 148 cm without shoes or 149 cm with shoes must provide a USEF Dressage Pony Measurement Card or FEI Pony Measurement Card, or be measured by an eligible Dressage Technical Delegate and/or competition veterinarian per USEF GR 505, 506, and 508. Failure to allow a pony to be measured will result in the pony being disqualified. Entries into Junior/Young Rider and Adult Amateur classes MUST meet the definition per USEF rules. Adult Amateur entries must include proof of current USEF Adult Amateur card. If entry does not designate a Junior/Young Rider or Adult Amateur status, the rider will be entered in the Open category. In the case of Adult Amateur, if the entry omits proof of current USEF Adult Amateur status, the rider will be entered in the Open category. **ALL CREDENTIALS MUST BE AVAILABLE FOR VISUAL INSPECTION AND INCLUDED WITH ENTRY.** To avoid the DDC non-member fee, the rider MUST be a current DDC member at the time of the show or pay a \$10 DDC non-member fee.

RIDE TIMES: Tentative ride times will posted on the Dallas Dressage Club website on Friday, July 24, 2009. Official ride times for each competition will be posted at the Show Office by noon the previous day. Please visit www.dallasdressage.org for prize list corrections, addendums, and updated Event information.

REFUNDS: Refunds will be given from opening date up to the closing date less office fee. No refunds of any kind for any reason including Act of God will be given after the closing date and throughout the competition. Absolutely NO refunds will be made at the show. Refunds will be mailed within thirty (30) days of the conclusion of the Event by the Dallas Dressage Club (Treasurer).

USDF Membership Benefits: USDF is dedicated to education, recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the USDF Directory or the USDF web site at www.usdf.org.

Membership Requirements for USDF – recognized/USEF-Licensed Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USDF-recognized/USEF –Licensed Competitions as a rider or owner/lessee, must have either a USDF Group Membership (GM), Intercollegiate/Interscholastic Membership (IM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF NM fee. Note: USDF Business Members (BM) can own horses but cannot compete as riders with their BM.

Horses competing at USDF-recognized/USEF –Licensed Competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Exceptions:

- Horses competing only in Individual Breed Classes (IBC) at DSHB competitions, horses competing only in breed restricted dressage or DSHB classes at Regular competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, Pas de Deux, Quadrille, or FEI Para Equestrian classes are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot and academy classes. For foreign-owned horse competing in CDI, USDF accepts copies of the horse identification pages from an FEI passport in lieu of a USDF HID or Lifetime Horse Registration (LHR) number
- Riders and owners/lessees competing in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$62), 5-year (\$250), or life (\$1,000). A USDF Youth Participating Membership (YPM) is available for members under 21 (as of December 1 of the current membership year) for \$35. A PM allows the member to compete at USDF recognized/USEF-licensed competitions and participate in the USDF Rider Awards program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USDF recognized/USEF-licensed competitions and participate in the USDF Rider Awards program.

Intercollegiate/Interscholastic Membership (IM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Intercollegiate/Interscholastic Member Organization (IMO). The membership year is December 1 through November 30. An IM allows the member to compete at USDF recognized/USEF-licensed competitions and participate in the USDF Rider Awards program.

Business Membership: A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$175) offers a wider variety of advertising benefits. BSs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF non-member owner/lessee and USDF non-member rider there will be a USDF non-member fee of \$20 and a USDF non-member form per competition that must be collected by the show secretary and submitted to USDF along with the USDF Report of Fees document and the \$5 affidavit fee if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the non-member requirements are also exempt from paying the USDF non-member fee. If all the owners of the horse are non-members, only one of the owners must pay the non-member fee. If the horse has at least one owner who is a current USDF member, there is no non-member fee assessed. Competition management will be invoiced for all applicable USDF non-member fees not received with the USDF post competition paperwork, along with a report listing all USDF non-members. Competition management is then required to submit the non-member fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF web site.

Horse Identification (HID) Number: A one-time tracking number for horses (\$20). Scores earned by a horse with an HID will be recorded, but will NOT be counted towards Adequan/USDF Year-End Awards. A horse with an HID is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders Championship Series Finals. An HID can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$65. If a horse has a USDF LHR it does not need an HID. An HID does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with a LHR (\$85) is eligible for Adequan/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has a LHR it does not need an HID. A LHR does not need to be renewed.

How to Join USDF

Applications for participating membership (PM), business membership (BM), non member (NM) identification number, horse identification (HID) number, and lifetime horse registration (LHR) may be found in the following locations.

- On the USDF web site: www.usdf.org. You can submit the application online, print, fax, or mail it.
- In the show office at USDF-recognized/USEF-licensed competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the forms and correct fees are received in the USDF office or, if applying at a competition, the date received by the competition secretary.

CLASSES, DIVISIONS, AND QUALIFYING CLASSES

The following classes will be offered in Open, Adult Amateur, and Junior/Young Rider divisions except where restricted by age or USEF rules. Classes with less than three (3) entries may be combined or cancelled as necessary. Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.

Division Definitions

Junior Rider (JR): Open to riders through the year that they turn age 18. Juniors riding FEI tests must be 14-18 years of age.

Young Rider (YR): Open to riders beginning in the calendar year in which they reach the age of 16 through the year that they turn age 21.

Adult Amateur (AA): Open to Adult Amateurs only, competitors must compete as adults from the beginning of the calendar year in which they reach the age of 22., must hold current USEF Amateur Card.

Open (O):

Pony (P): Ponies not exceeding 148 cm without shoes or 149 cm with shoes must possess a copy of the USEF Dressage Pony Measurement Card or be measured by an eligible Dressage Technical Delegate and/or competition veterinarian. All credentials must be available for visual inspection and included with entry.

Championship Qualifying Classes

Great American Insurance Group/USDF Regional Championship (GAIG) qualifying classes and Southwest Dressage Championship (SWDC) qualifying classes will be ridden concurrently with the non-qualifying classes corresponding to the same level and test. **Eligible competitors must designate their entry as “Great American/USDF Qualifying” on the entry form and submit documentation to verify eligibility to enter the class. Add an additional \$10 to entry fee for this class. For SWDC, competitors must designate their entry as “SWDC Qualifying” and add an additional \$6 entry fee for class.**

Note: For Great American/USDF qualifying classes, rider and owner **MUST** be USEF Senior, Junior, or Life Members and **MUST** be USDF participating or Business Members. The horse **MUST** be lifetime registered with USDF and Life or Annual USEF recorded. Horse Identification Number is **NOT** acceptable.

LEMONADE DAZE AWARDS

CLASS RIBBONS/TROPHIES: Trophies will be awarded for 1st Place and ribbons will be awarded for 1st – 6th Place in accordance with the current USEF Rules. In case of equality of points, the competitor with the highest marks received under General Impressions shall be declared the winner. When the scores for General Impressions are equal the horses must remain tied (DR 123.3).

CHAMPIONSHIP AWARDS: A Champion and Reserve Champion will be designated at Training through Fourth Level, FEI, and Freestyle. Riders will compete for Champion and Reserve Champion without regard to Division (Junior, Adult Amateur, Open) except at Training, First, and Second Level for which a separate Junior Division Champion and Reserve will be awarded. A minimum of three riders must compete at a level (regardless of Division) before a Champion award will be presented. Training through Fourth Level Champion/Reserve Champion will be determined by averaging all scores by horse/rider combination at a particular Level (Training thru Fourth). Competitors must have at least two (2) scores to qualify for designation as Champion or Reserve Champion. The average of all scores MUST be 55% or higher to be included in the calculation. FEI Champion and Reserve Champion will be determined by using a single score from a PSG, I1, I2, GP, FEI, Junior Individual, FEI YR Individual, FEI Junior Team, or FEI YR Team Test ride. FEI Young Horse rides will not count for FEI Champion/Reserve Champion. The average of all scores MUST be 55% or higher to be included in the calculation. Freestyle Champion and Reserve Champion will be determined by using scores from USDF 1st through 4th Level Freestyle, FEI Freestyle (PSG, I1, I2, GP), FEI Junior and YR Freestyle, and IPEC Freestyle. Freestyle for PSG, I1, I2, GP, FEI Junior and YR will be counted towards Freestyle Champion, not FEI Champion. The average of all scores MUST be 55% or higher to be included in the calculation.

DDC HIGH SCORE AWARD: An overall high score award for each show weekend will be presented for the single highest score for a Training through 4th Level Test, and one for the single highest FEI Level score (PSG, I1, I2, or GP) by a DDC member. Scores MUST be 55% or higher to be considered.

THE 2009 USDF/DOVER SADDLERY ADULT AMATEUR MEDAL

The USDF/Dover Saddlery Adult Amateur Medal Program is designed specifically to recognize and encourage Adult Amateurs riding at Second Level. For additional information and an updated list of competitions offering the USDF/Dover Adult Amateur Medal Program, please visit the USDF website at www.usdf.org/programs/doveradultamateurmedal.asp.

DOVER MEDAL RECIPIENT: The eligible rider with the highest score of 58% or better in the designated Second Level Test Three class or applicable test of choice USDF/Dover Adult Medal class at a participating competition will receive a handcrafted USDF/Dover pewter medal and neck ribbon. Winners will receive a \$20 Dover Saddlery gift certificate for the first three (3) USDF/Dover Adult Medals they win during the 2009 competition season.

THE USDF/DOVER NATIONAL MERIT AWARD: A USDF/Dover National Merit Award will be awarded to riders winning three (3) USDF/Dover medals in the same competition year.

YEAR END AWARDS: The USDF/Dover Medal National Champion and Reserve Champion are determined from the average of the top three (3) winning ride scores during the competition year. The Champion receives a \$1,000 Dover Saddlery gift certificate and a Dressage saddle. The Reserve Champion receives a \$500 Dover Saddlery gift certificate and a Dressage bridle.

RIDER ELIGIBILITY: To be eligible to compete, rider MUST meet the following criteria; (1) Rider MUST be a current USDF Group, Participating, or Intercollegiate/Interscholastic member at the time of the competition, (2) Rider MUST ride a Second Level Test 3, (3) Rider MUST be an Adult Amateur in accordance with USEF GR 1306 and be designated with USEF as an Adult Amateur as of the competition date.

The designated USDF/Dover Adult Medal Classes (Second Level Test 3) at the Lemonade Daze I and II are Class 223 (Saturday) and Class 323 (Sunday).

SHOW INFORMATION AND RULES

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

STABLING: Permanent stalls measure approximately 10' by 10', with Dutch or sliding doors and wood floors. Any stall which is altered (e.g. removal of the door) must be restored to the original state or entrant will be charged an additional \$25. Entrants who fail to immediately correct unsafe situations/practices in stabling area (e.g. unsafe extension cords) as identified by Competition Management will be fined \$50/incident. Stalls will be available beginning at noon on July 23 (THURSDAY) and MUST be vacated no later than 7 pm on July 26 (SUNDAY). Early/late arrivals and departures MUST be made through Show Manager by calling 469-628-3754. Entrants NOT purchasing bedding from LCEC will be charged a \$15 stall cleaning fee.

SHARPS DISPOSAL: Management shall provide at least one sharps container per fifty (50) occupied stalls in the stabling area for competitor's use. Competition Management may fine any individuals (including trainers, owners, exhibitors, and/or their agents) up to \$100 for improper disposal of needles and/or other sharp disposable instruments.

ARENA DIMENSIONS/FOOTING: Ring 1 is covered 20 m x 60 m Dressage arena with all weather sand/clay footing. Warm up for Ring 1 is covered arena with sand/clay footing. Ring 2 is outdoor 20 m x 60 m Dressage arena with all weather sand footing. Ring 3 is outdoor 20 m x 60 m Dressage arena with all weather sand footing. Warm up for Ring 2 and Ring 3 is outdoor arena with sand footing. Introductory and Training Level (non-qualifying) classes will be ridden in 20 m x 40 m Dressage arena. Lunging allowed in designated area only. **Management reserves the right to make whatever changes deemed necessary to the arena configuration in order to accommodate show entries and/or weather conditions.**

FARRIER/VETERINARIAN: A veterinarian and farrier will be on call during competition. Contact information will be posted at the Show Office. Any horse that develops a communicable disease may be removed at the Management's discretion. Competition Management will assume no responsibility for the health of horses being stalled. Owners enter horses at their own risk.

PARAMEDIC PERSONNEL: A first aid provider will be present on the grounds Saturday and Sunday, 30 minutes prior to the start of the competition until the conclusion of competition day. First aid provider will NOT be present on grounds on Friday.

DOGS: All dogs MUST be on a leash and attached to a responsible adult at all times. Proof of current rabies vaccination is mandatory – no exceptions. Violations of this rule will result in requesting the removal of the dog from the premises and a mandatory \$20 fine. Unattended dogs may be confined to a community animal shelter if Show Management deems necessary.

CONCESSIONS: On site concessions will be available 30 minutes prior to the competition start time until the conclusion of the competition day.

MOTORIZED VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of a licensed competition. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent (s), guardian (s), and/or trainer (s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent (s), guardian (s), and/or trainer (s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with USEF Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Show Management reserve the right to add, combine or divide classes, add or substitute judges or make any changes required by circumstances. Show Management reserves the right to refuse or require withdrawal of any entry for cause deemed sufficient by the Show Management. Show Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accident or emergency. Every effort will be made to reschedule with priority given to any Championship or qualifying classes being offered.

United States Equestrian Federation Membership Statement

Every class offered herein, which is covered by the rules and specifications of the current United States Equestrian rule book will be conducted and judged in accordance therewith.

Life, senior, active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions, and Combined Driving Competitions upon payment of a \$30 non-member registration fee. Participants in the following classes are exempted from the requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA endorsed reining competitions; 8) opportunity classes; 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation; 10) USEA beginner novice division; 11) assistant handlers in Dressage Sport Horse Breeding classes.

Federation Entry Agreement

By entering a Federation Licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulting, or Longeur, and on behalf of myself and my principles, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of the Competition. I agree to be bound by the Bylaws and Rules of the Federation and of the Competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the Competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the Competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation Rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR 908.4.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 125 independent organizations throughout the United States with a membership in excess of 33,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

2009 Great American Insurance Group/ USDF Regional Dressage Championships

In 2009, a single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), licensed by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a GMO is received by April 1 of the prior year.

Membership/Registration Requirements for Qualifying & Championships

Rider:

- Must be a USDF Participating Member at the time qualifying scores are earned and at the time of the Championships.
- Must be a USEF Member (Junior Active, Senior Active, or Life) at the time qualifying scores are earned and at the time of the Championships.

Horse:

- Must be USDF Lifetime Registered at the time the qualifying scores are earned and at the time of the Championships. Horse Registration must be in the name (s) of the current owner (s) or lessee (s) of record. If a current lease recording is on file with USDF, the lessee is recognized as “owner” for all USDF membership requirements.
- Must be USEF (Annual or Lifetime) recorded at the time qualifying scores are earned and at the time of the Championships. Horse recording must be in the name (s) of the current owner (s) or lessee (s) of record.
- Horse DOES NOT have to be breed registered.

Owner:

- Must be a USDF member (Participating or Business) at the time the qualifying scores are earned and at the time of the championships.
- Must be USEF member (Junior Active, Senior Active, or Life) at the time qualifying scores are earned and at the time of the Championships.

**Participating Members are USDF members who join USDF directly*

2009 Minimum Qualifying Scores

One set of nationally standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Levels through Grand Prix, in three (3) divisions: Open, Adult Amateur, and Junior/Young Rider. FEI Junior Rider and FEI Young Rider classes have only one respective division. Freestyles have only Open division. The minimum percentages are as follows:

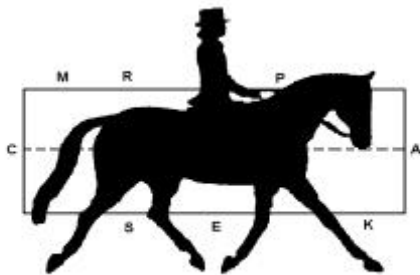
Southwest Dressage Championship Qualifying Classes will be governed by the rules published in the current SWDC/Region 9 Omnibus and/or on web site www.swdressage.org. Each rider must declare the division in which they are competing prior to each attempt at a qualifying ride at SWDC qualifying shows or for a score submitted under the rules (Amateur, Open, or Junior/Young Rider) and must provide proof of eligibility in the case of Amateur and Junior/Young Riders. Adult Amateur and Junior/Young Riders may also qualify for the Open division. Separate scores must be earned for each division. At the Championships, they must enter each division separately although they will only ride once. There is no requirement of citizenship or horse/rider/owner registrations for SWDC, but each horse/rider pair must comply with USEF and competition rules.
